The purpose of this notice is to inform you that Los Angeles County Superior Court Judge Helen I. Bendix has granted final approval of the Stipulation For Class Action Settlement (“Settlement”) in the civil action captioned Rosalie Casanova v. Gregg Industries, Case No. BC337037 (the “Action”).

If you were employed as an hourly employee at Gregg Industries’ El Monte, California facility between July 25, 2001 to present, and did not opt-out of the settlement, you are a member of the Class and may qualify for a monetary award as a result of this settlement. In order to seek an award, YOU MUST TIMELY SUBMIT A COMPLETED AND SIGNED CLAIM FORM AND A COMPLETED AND SIGNED RELEASE FORM.

A Claim Form with instructions and a Release Form with instructions were previously sent to you with the Notice of Pending Class Action Settlement (the “Notice”). The Notice set forth the formula used to determine your share of the Settlement Fund. The Claim Form and the Release Form must both be delivered to the Claims Administrator by **March 17, 2008** at the address below:
